The CMM is in the Millbrook Mi'kmaw Community in Nova Scotia and has over 100 Employees. The CMM's Department of Community Services & Infrastructure is currently looking for an energetic, mature, and independent candidate to fill the role of an *Infrastructure Program Manager*.

Position Overview

Reporting to the CMM Director of Community Services & Infrastructure, the CMM Infrastructure Program will be responsible for developing, implementing, and overseeing Infrastructure programming and services of importance to CMM and its Member Communities, through collaboration with the Infrastructure Advisory Committee. The Infrastructure services component of the organization is currently in the developmental stage and offers exciting and dynamic opportunities for the successful candidate. His/her responsibilities will include, at a minimum, the ACRS (Asset Condition Reporting System), Maintenance Management, Asset Management, Capital Planning, and Emergency Measures. CMM will become an information hub for all community asset information.
